General Information OF “2011 HAPPY TRAIL IN KOREA”

1. History of Happy Trail in Korea(HTK) : Holt Motherland Camp

As they get older, many overseas adoptees seek to learn more about their motherland and heritage. In 1992, the first Holt Motherland Camp was held in hope to offer young adult overseas adoptees with an opportunity to visit Korea, learning its culture, customs, and history.

For the past 20 years, with the increasing interest and participation of overseas Korean adoptees from around the world, Holt Motherland Camp: Happy Trail in Korea has successfully been able to mature and evolve to provide better programs for the adoptees to experience and see their motherland beyond their scope. This year in particular, we welcome you to celebrate our 20th anniversary with us. It is our sincere hope that this program will continue to grow for many more years in effort to reach adult overseas adoptees who wish to enrich and broaden their understanding of Korea, their motherland.

2. General information of 2011 Happy Trail in Korea

***Time:** July 13rd ~ 26th (14days)

***Location:** Grand Hilton Hotel in Seoul (Equivalent Hotel Substitutable)

***Participants:** For all adoptees who has not previously participated in other cultural camps/programs in Korea

***Number of Participants:** 25 adoptees from the U.S. and European countries

***Recommendation (Required):** One recommendation must be from the following,

- a. a director of your local adoption agency or
- b. the President or Secretary of adoptee association or
- c. employer, school personnel, or direct supervisor

* Holt Children's Services reserves the right to review and select the qualifying candidates.

***Language:** English and Korean will predominantly spoken during the entire camp.

***Registration Fee :** \$100/€75 is required along with the application

(Payment can be done through personal check/money order)

- ⊙ Participants are responsible for their airfare and personal expenses

***Application Deadline :** May, 31, 2011

4. Helpful Information

* This program can be altered without any advanced notice

Once you arrive at the Incheon Int'l Airport, you may directly come to the Hotel by using airport limousine or taxis. Two participants will share a room. There will also be a kitchen available for you to cook your favorite dishes and washer.

Except for the airfares and personal expense and registration fee, all other costs are paid by Holt.

For the current exchange rate, please check the internet for the latest information, but as of now it is (US\$1.00=1100won). Traveler's checks are the easiest and the fastest for currency exchange. You may also use credit cards, but only in limited places such as designated ATM machines and at some banks.

In the case you need to make personal calls back home, please check your country code, area code, and the telephone number before coming to Korea. You can purchase international phone cards at the airport or any local convenient stores in Korea.

You will also have an opportunity to experience what a Korean family life is like through Homestay.

Here you will have first-hand experience with Korean family life. Most host family can speak some English although they may not be fluent. You may want to bring pictures of your family and friends or home country to share with them.

We also recommend that you to speak with friends or other students who are familiar with our program for possible feedbacks.

During the program, we will schedule for you to review your adoption file with Holt case workers. You will receive information regarding your adoption history. You may or may not have an opportunity to meet a foster mother, birth family or visit the orphanage where you were referred from. The crucial factor that determines for a possible reunion or visit is how much identifying information was left at the time of placement as well as their present circumstances after many years of changes in cities).

“Happy Trail in Korea” schedule is filled with various activities and travelling; therefore, it may be difficult to change your airplane ticket if you decided to stay longer. Please plan well in advance if you choose to do so.

We recommend that you will look into or research books/internet about Korea to further prepare yourself before your visit to Korea. It is also a good idea to bring with you a travel guide on Korea. One part of Korean culture that may be helpful for you to know ahead is that the pace is more of a "go with the flow" when travelling.
